This Trial is open to all dogs over the age of 6 months that are registered with the American Kennel Club (including mixed breeds), or are a registerable breed that has obtained an AKC, ILP, PAL or MA number; except bitches in season, aggressive dogs or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. Dogs that are blind or deaf shall not be eligible. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes.

Dogs under 6 months of age are not permitted on show grounds.

All competitors through entry at this event waive any and all rights relative to photo/ video broadcast of this event. Competitors shall have the right to videotape/photo portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes. All video, broadcast, and telecast rights for this event are the exclusive property of Suffolk Obedience Training Club.

NOTICE TO EXHIBITORS

Please double check your entry forms before sending them in. We WILL NOT process entries with the following issues:

- Overnight deliveries must be "No Signature Required"
- Entries received without correct fees
- Unreadable handwriting
- Incomplete owner or dog information
- Incomplete class list please list ALL classes you are entering.
- Missing jump height when required for class entered.
- Entries not on an official AKC entry form or photocopies of an entry form without the agreement

If you are unsure if your writing is legible, please ask a friend to look at it before sending in your entry. We have had a lot of difficulty deciphering handwriting.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.
